The Correspondents of the Private Aided Degree / P.G. / Oriental Colleges in the State are informed that the financial year 2014-2015 is completed. As per A.P. Private Educational institutions (inspection, Accounts and return) Commissioner of Collegiate Education is the competent authority to conduct of Accounts of every Educational institution (Degree, P.G., and Oriental Colleges) receiving grants out of the State funds. It is mandatory for the management of Private Aided Colleges to submit the financial statement by the end of May / June of the succeeding financial year, containing supporting statements for the income and expenditure shown in the balance sheet.

As the financial year 2014-2015 is completed, the Correspondents are requested to furnish the financial statement for the year 2014-2015 immediately so as to reach on or before 31.07.2015 and keep all the records, Bank Pass Books / Reconciliation Statements (Tuition fee / Special Fee / Scholarships / U.G.C. accounts etc.) ready for audit of the accounts of their Colleges from August 2015 onwards. The financial statements should be sent in full shape containing 43 statements. Incomplete financial statement will not be accepted.

The managements are informed that if the financial statement is not received by 31-07-2015, the A.T.G. will not be released to the defaulter colleges and the matter will be dealt with in terms of Section 46 of A.P. Education Act. 1982.

Further, certain Correspondents / Principals are not submitted the previous year's financial statements, which is irregular and liable to be punishable as per existing rules. Therefore, the Correspondents / Principal are once again directed to submit the previous year's financial statements if any pending within the stipulated time i.e. on or before 31.7.2015 without fail, failing which action will be initiated without any notice.

This should be treated as URGENT.
