In the reference 1<sup>st</sup> read above Government have issued orders allowing revised UGC Scales 2006 w.e.f. 01.01.2006 to the teaching staff working in University and undergraduate Colleges in the State. In the reference 2<sup>nd</sup> read above Government have issued orders for implementation of UGC Regulations 2010 w.e.f. 30.06.2010 duly substituting the existing Appendix to G.O 1<sup>st</sup> read above.

In pursuance of the Government orders 2<sup>nd</sup> read above and Government clarification 3<sup>rd</sup> read above, the guidelines for award of Senior Scale (Pay Band of Rs.15600-39100 + 7000 AGP) and Selection Grade Scale (Pay Band of Rs.15600-39100 + 8000 AGP) fixation of pay under Career Advancement Scheme, eligibility criteria, selection procedure were communicated to all the Government and Aided Degree Colleges in the State with directions to obtain applications from the qualified & eligible Lecturers working in the respective colleges, including the left over cases, who gets eligibility upto 30.06.2010 and submit them to this office by online and by postal service on or before 15.05.2017. The last date for submission of applications was revised to 15.06.2017 vide reference 6<sup>th</sup> read above.

In the reference 8<sup>th</sup> read above orders were issued awarding 7000/- (Stage II) and 8000/- (Stage III) to the Lecturers of Government and Aided Degree Colleges in the State. In the reference 8<sup>th</sup> read above, the provisional list of lecturers for award of 9000/- AGP and 10000/- AGP were communicated and after examination of the grievances of the individuals, probable dates for selection were communicated to the individuals vide reference 10<sup>th</sup> read above.

In the reference 11<sup>th</sup> read above, the Selection Committees constituted for awarding Stage - IV i.e 9000/- AGP with pay of Rs. 37400 - 67000 and Stage - V i.e. 10000/- AGP with pay of Rs. Rs. 37400 - 67000 to the Lectures were convened from 28.04.2018 to 08.05.2018 and interview the lecturers who have attended for the selections. The said Selection Committees have finalized the list of eligible and ineligible Lecturers for the said pay scales.

Therefore, in pursuance of the minutes of the Selection Committees the list of names of lecturers selected by the Selection Committee for award of Stage - IV i.e 9000/- AGP with pay of Rs. 37400 - 67000 or Stage - V i.e. 10000/- AGP with pay of Rs. Rs. 37400 - 67000 or both under Career Advancement Scheme are awarded to the Lecturers of Government and Aided Degree Colleges in the State from the dates shown against their names in the Annexure appended to these orders, subject to the condition that:

- i) that the re-designation of the Lecturers as Assistant Professors / Associate Professors / Professors will be issued separately.
- ii) that the lecturers who are now allowed 10000/- AGP (Stage - V) cannot claim the post of Principal just because they are allowed the 10000/- AGP.
- iii) that if the pay now allowed (AGP 9000/- Stage - IV or AGP 10000/- Stage - V) is found irregular at a later date the same will be reviewed and revised as per rules besides recovery of the amount accrued due to fixation of pay based on the date now awarded from the individual concerned without assigning any notice to the individual besides recovery of the amount.

The Principals of Government Degree Colleges and Correspondents of Aided Degree Colleges in the State are requested to communicate the orders to the individuals concerned under proper acknowledgement and submit proposals for fixation of pay in respect of the individual to the Regional Joint Director of Collegiate Education concerned strictly following the date so awarded in this proceedings.

The Principals of Government Degree Colleges and Correspondents of Aided Degree Colleges in the State are informed that in case if the name of any individual, who has submitted proposal through the specified modes of submission before the due date, is missing in the selection list now communicated, the cases of such persons will be examined separately and placed before the next Selection Committee for approval and orders will be issued to those cases separately based on the approval of Selection Committee.

The original Service Registers of the individuals received in the office for this purpose will be returned to the respective college through the Principals of Identified Government Degree Colleges concerned. The Principals of identified Government Degree College concerned is requested to depute one office staff from their college to collect the service registers of the lecturers from this office and handover the service registers to the colleges concerned under proper acknowledgement.
